

## PICK YOUR PRIZE PROMOTION

### TERMS & CONDITIONS

Information on how to enter and prizes form part of these terms and conditions. Entry into this promotion is deemed to be acceptance of these terms and conditions.

1. Entry is open to all Brisbane residents permanently residing in Brisbane.
  - a) If under 18 years of age, have obtained permission from their parent or guardian and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions.
  - b) Employees (or immediate family of such employees), Directors and their immediate families of the Promoter and printers, suppliers, providers and agencies associated with this promotion are not eligible to enter.
2. The competition (Promotional Period) commences on 04/06/2018 and concludes 15/06/2018 at 5.00pm AEST.
3. To enter, entrants must, during the Promotional Period:
  - a) Spend \$10 in one transaction in one day with any participating Valley Metro Retailer;
  - b) When customers reach the spend threshold of \$10 they will be provided an entry form by the retailer;
  - c) Accept the terms and conditions checkbox; and
  - d) Submit entry (including full name, phone number, email address and postcode) into the entry barrel in the Valley Metro food court
  - e) Winner will be drawn by random selection.
4. Personal information disclosed is provided to Valley Metro.
5. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
6. Incomplete, indecipherable, or illegible entries will be deemed invalid as will entries containing expletives.
7. Participant may enter as many times as they like.
8. The winner will be contacted by telephone and/or email.
9. Prize winner: The winner will be awarded from random draw.
10. The winner will receive their choice of the following prizes:
  - a) A single, one year, unreserved parking pass at Valley Metro Secure Parking; OR
  - b) \$1000 worth of travel supplied on Go Cards ; OR
  - c) A \$500 eftpos giftcard

12. The prizes are not transferable or exchangeable and cannot be taken as cash. If for any reason a winner does not take the prize within the time stipulated by the terms and conditions of the prize, then the prize will be forfeited and a new winner drawn.
13. The Promoter has up to 30 days to complete delivery of the winner's chosen prize.
14. The Promoter reserves the right to redraw any unclaimed prize in the event of an Entrant failing to comply with these Conditions of Entry or forfeiting or not claiming the prize within 8 days after notification of the winning Entrant. If the prize remains unclaimed by the 23/06/2018, then

another winner will be drawn at random and will be contacted the day after the Unclaimed Date.

15. If the prize is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize with a prize of equal value and/or specification.
16. Prizes, or any unused prize, are not transferable or exchangeable and cannot be taken as cash, unless otherwise specified.

Entrants consent to the Promoter using the entrant's name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this completion (including any outcome), and promote any products manufactured, distributed and/or supplied by the Promoter.
18. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) to modify, suspend, terminate or cancel the promotion, as appropriate.

The Promoter reserves the right to verify the validity of entries and to disqualify any entry which, in the opinion of the Promoter, includes objectionable content, profanity, potentially insulting, inflammatory or defamatory statements, disqualify any entrant who tampers with the entry process, who submits an entry that is not in accordance with these Terms & Conditions of Entry or who has, in the opinion of Promoter, engaged in conduct in entering the Promotion which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the Promotion and/or Promoter. The Promoter reserves the right to disqualify a winner if Promoter becomes aware that the winner and/or the winner's entry is of a type described in this clause.

Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury or death, or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; (f) the acceptance or use of a prize; (g) any act or omission of the Promoter or its associated agencies.
21. Once the prize has been claimed and received by the winner it becomes the responsibility of the winner. Any prizes which are lost or stolen will not be replaced.
22. As a condition of accepting the prize, the winner (and any companions) may be asked to sign any legal documentation as and in the form required by the Promoter / Prize Supplier / organisers in their absolute discretion including but not limited to a legal release and indemnity form.
